**RESOLUTION NO. 2954.24**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING THE PURCHASE AND EQUIPPING OF ONE HYUNDAI PALISADE VEHICLE FOR THE DETECTIVE UNIT OF THE GOLDEN BEACH POLICE DEPARTMENT, AND THE USE OF GENERAL FUNDS TO PURCHASE AND EQUIP THE VEHICLE; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town desires to purchase one (1) Hyundai Palisade vehicle for the Detective Unit of the Golden Beach Police Department in order continue to provide service and police protection to the residents of Golden Beach; and

**WHEREAS**, the cost to the Town to purchase and equip One Hyundai Palisade is projected to be \$54,809.00, includes: One Hyundai Palisade vehicle – with a purchase cost of \$49,809.00; emergency equipment - purchase and installation for the Hyundai Palisade cost not to exceed an additional \$ 5,000.00 for a total average cost of \$54,809.00; and

**WHEREAS**, the Town Council desires to utilize General funds to pay for the vehicle for the Detective Unit of the Golden Beach Police Department; and

**WHEREAS**, the Chief of Police has recommended that the \$54,809.00 cost be taken from the Town's General Fund; and

**WHEREAS**, the Town Council finds that it is in the best interest of the Town to proceed as indicated in this Resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals Adopted.** That each of the above-stated recitals is

hereby adopted and confirmed.

**Section 2. Authorization of Approval.** The approval and execution of the purchase agreement of a Hyundai Palisade Detective vehicle, as described and outlined in the Agenda Item Report attached and incorporated herein, is hereby authorized and approved.

**Section 3. Implementation.** That the Mayor and Town Manager are authorized to take any and all action which is necessary to implement this Resolution.

**Section 4. Effective Date.** That this Resolution shall be effective immediately upon adoption.



### **Recommendation:**

It is recommended that the Town Council adopt the attached Resolution No. 2954.24 as presented.

### **Background and History:**

The Chief of Police has requested the purchase of one (1) Hyundai Palisade vehicle with emergency equipment for the Detective Unit.

In not purchasing a Chevy Tahoe for this unit, the Town is mirroring what neighboring agencies have deployed for their investigative staff. As an example, the investigations unit of our neighboring agency (Sunny Isles Police Department) has already transitioned to using the Hyundai Palisade vehicle, to much success. This switch has assisted in ensuring that their undercover vehicles are less recognizable as traditional police vehicles.

### **Financial Impact:**

An amount not to exceed \$54,809.00 for the purchase of a Hyundai Palisade Detective Vehicle with an emergency equipment package.
